# Bennachie Community Council Minutes of the Meeting held on 27 January 2020

## Item 1 - Declarations of Interest

1. After asking for clarification on 'Declarations of Interest' from Aberdeenshire Council (AC) the Chair received Code of Conduct for Community Councillors & Councillors weblinks. Chair & Sec to read through guidance and provide a summary to Community Councillors. It was also suggested this should be included in the Community Councillors Induction Pack (which is currently being compiled).

## Item 2 - Minutes of the Last Meeting

4. The minutes of 25 November 19 were agreed. Proposed: Wally Rhodes; Seconded: Scott Ewan.

## Item 3 - Police Report

5. The Chair read out items from the Police Report (Annex A). Wally to put up the part of the report which relates to general advice such as phone scams on BCC Notice Boards.

## Item 4 - BCC Business

6. Decisions Since Last Meeting None apart from Planning Decisions - see Item 5 Planning below.

7. Financial Statement Wally advised there had been no significant change in the accounts and the balance is predicted to be ~£3500 for year end. Wally also advised year end was now end of March (in-line with AC year end) and reminded everyone to claim operational BCC expenses (e.g. printing, travel to site visits, etc).

8. Important Dates The Chair ran through the list of forthcoming important dates which had been circulated.

## Item 5 - Planning

9. Planning Applications Stuart provided a summary of the 15 applications since the last meeting in November, which had been circulated by email prior to the meeting.

a). APP/2019/2585 Land Adjacent to Oor Neuk Oyne and APP/2019/2759 Site at Loan of Durno.

Durno – Stuart had submitted objections on behalf of the BCC. Awaiting AC decision.

b). APP/2019/2772 Hillbrae, Culsalmond Stan declared an interest in this application and stepped out of the meeting. After discussions it was agreed that no action was required.

c). APP/2019/2878 Site at Mains of Rothmaise, Culsalmond The original application in July 2019 was for 4 houses and BCC had lodged an objection. This application is for 3 houses. After discussion it was agreed that no action was required.

d). APP/2019/2054 Erection of 3 Dwelling Houses (Plots6-8) Mortimer's Way Auchleven Frank advised that Alan Grant Grampian Ltd had gone into administration. Concern was expressed that planning permission may have been granted to a company that was in administration. Stuart to investigate.

e). LDP2021 Stuart provided an update on the LDP2021. Due to the new Aberdeen City & Shire Strategic Development Plan (SDP) taking longer than expected, it is unlikely to be completed until early in the new year. Since the PLDP must conform with comments in the SDP examination report, the PLDP consultation will also be delayed, probably until the end of Q1 2020.

f). National Planning Framework 4 (NPF4) Stuart advised that the last plan (NPF3) took place in 2014. As these are related to 'large-scale' (e.g. National Development sites) no action was required.

g). Stuart discussed the importance of independent research, including site visits, in accessing planning applications. A number of site visits had taken place since the last meeting with the Chair thanking Stuart, Alan and Wilma for these.

#### **Item 6 – Roads and Transport**

10. Dualling of A96 Stuart and Stan gave an update on the status of the A96 dualling. Based on the last public consultation events in May 2019 it was anticipated the preferred route option would be announced in October 2019. After contacting AmeyARUP, the delay appears to be due to AmeyARUP being inundated with Freedom of Information (FoI) requests. When pushed for a date timings given ranged from Easter 2020 to 'sometime' in 2020.

11. Dualling A96 - Alignment of Oyne / Colpy Routes Stuart gave an summary of potentially 'new' information relating to the Alignment of the Oyne / Colpy section of the A96 Dualling, which could potentially effect traffic flow through Inch. It is unclear if this information was available during the public consultation period. Stuart to research and provide a summary.

14. Waste Management The Chair had made contact with Norman (Nom) Wright (Community Waste Officer) who has agreed to attend our next meeting in February. The Chair to submit questions to Nom prior to the meeting.

15. Fly Tipping The issue of fly tipping was raised by Wendy (General Rubbish at Chapel of Garioch) and Scott (Asbestos at Back of Bennachie, Oyne). Scott shared information from a Freedom of Information (FoI) request he submitted to AC earlier in January. The following three specific questions were asked, with AC responses summarised:

- *Has reported fly tipping of asbestos and tyres increased since 3<sup>rd</sup> June 2019 (if so what %)*
- *Has reported fly tipping in general increased since 3<sup>rd</sup> June 2019 (if so what %).*
- AC Summary Response: Answer to both questions - 'No'.
- *What was the cost to Aberdeenshire Council in dealing with the removal and disposal of fly tipping in the last 3 year?*
- AC Summary Response: AC did not specifically record the cost of dealing with the removal and disposal of fly tipping, it is part of a wider budget that deals with street cleansing in general.

Scott to create a Facebook / website post regarding fly tipping encouraging individuals to use AC REPORT IT system. Chair advised that she had already contacted the Baillies of Bennachie to ask if they were aware of any fly tipping locally.

### **Item 8 - Aberdeenshire Council**

16. Cllr Leslie indicated very tight budget constraints will once again be challenging, with cuts likely. Focus likely to be on Integrated Social Care and Education. Local recruitment of teachers had increased, however teacher retainment was a potential challenge with many moving on after relatively short periods of time (e.g. 2 years).

### **Item 9 - Chapel of Garioch**

17. Fly Tipping - see Item above.

18. A96 - Pitcaple / Whiteford Junction Speeding Steve Futter (Pitcaple Resident) raised concerns and gave an overview of the junctions off the A96 at Pitcaple (up to Chapel of Garioch and to Whiteford). In summary traffic speed and intensity has increased since the opening of the Inveramsy Bridge. The previous traffic lights gave breaks in traffic, whereas now it's a near continuous traffic stream. Both junctions are from a standing start into the flow of and / or across traffic on a 60mph road, in addition to reduced visibility in both directions. Prior to the meeting Steve had contacted the BCC asking for AC contact details. The Sec provided contact details for AC (Roads - Brian Strachan), Ward 10 Councillors and Police (Sargent MacLennan). The Chair also emailed these contacts. BCC Response from AC Roads: A96 is a main trunk road and comes under Bear Scotland ([enquiries@bearsotland.co.uk](mailto:enquiries@bearsotland.co.uk)). During the meeting suggestions for potential reduced speed limit and / or flashing junction sign (similar to that at Laurencekirk) were suggested. Wally confirmed speeding was a topic at the September CC Forum.

Actions: Steve to ascertain level of local feeling and report back to BCC. Wendy to aid Steve with contact information for Chapel of Garioch (e.g. village email, Facebook Page, notice boards etc). Once this is complete the Chair will write to Bear Scotland and Margaret-Jane Cardno (AC). Cllr Leslie also to follow up with AC and Bear Scotland.

21. Inch Train Station Survey. The Chair had been in contact with AECOM (Jo Duck) and Cllr Argyle expressing concern that the survey was not as expected, asking for an update and also re-stating the importance of the station upgrade to the community. AECOM advised that a report had been sent to Transport Scotland and they were awaiting feedback. The Executive Summary to be reported to NESTRANS Board on 12<sup>th</sup> February, after which the survey could be shared. The Chair to submit question to MSP Alexander Burnett via Annie Humphrey to raise concerns about the potential level of station upgrade.

## Bennachie Community Council Police Report for JANUARY 2020

### **Community Council Report**

This report covers progress we have made in dealing with your priorities for the Bennachie Community Council area during the period 27/11/2019 to 20/01/2020.

The report aims to highlight emerging issues in your area, and to provide crime prevention advice and guidance to Community Council members and residents you represent. Our focus is to reduce crime and disorder, help create safer communities and respond effectively to local concerns.

### **Community Policing Priorities**

#### **Antisocial behaviour, Violence and Disorder:**

On 09/01/2020 a Vandalism occurred at the TSB on West High Street, Inch where a sign was removed from its fixings. Enquiries are ongoing into this.

During this time we attended a few nuisance/disturbance calls within the area, none resulting in anything criminal. We also attended several assisting members of the public calls providing general advice and help.

#### **Acquisitive Crime:**

On 03/12/2019 a female had money and medication stolen from her handbag while it was unattended at a property on Commerce Street, Inch. Enquiries are ongoing into this.

On 10/12/2019 Police attended a Robbery at R S McColl, High Street, Inch where a male assaulted customer within. He was traced and dealt with at the time.

On 17/01/2020 a male failed to pay for a taxi on High Street, Inch. Enquiries are ongoing into this.

There have been no other reports of acquisitive crime during the time period.

#### **Road Safety & road crime:**

On 07/01/2020 on the A96 near Skares Farm a male was issued with a speeding ticket.

During this time period we attended several Road Traffic Collisions in the area, none resulting in injury or prosecution. We also attended several reports of erratic driving.

### **Community Engagement & Reassurance**

#### **Various fraud/scams**

There are numerous fraud and telephone based scams doing the rounds at the moment and I would ask that you encourage/remind that the bank/reputable organisations will not phone you

and request personal details over the phone. If there is any dubiety attend at your local branch. Do not transfer any money over the phone no matter how plausible these individuals may seem.

### **New mobile phone technology to increase police officer visibility in local communities**

Police officers in the North East will start using mobile devices as part of their operational duties which will increase their visibility within local communities.

Officers will be able to access a wide range of police systems while out on duty without the requirement to return to a police station and log on to a computer.

This means that officers will be able to spend more time working within the community, dealing with incidents, engaging with members of the public, supporting victims and focussing on crime prevention.

Previously, when officers dealt with a crime, they would have to return to base to record details of an incident on the appropriate systems and complete paperwork.

The new mobile devices will mean that every Community Policing Team officer, and those with a front line operational role, will be able to connect to police systems whilst working remotely.

The mobiles will provide apps enabling officers carry out checks and file crime reports. Officers will also be able to type statements directly to the device through the use of its digital notebook function Pronto which will obtain an electronic signature from victims and witnesses.

### **Bike security**

Keeping hold of your bike should be easy. More of us take to the roads as the better weather approaches so here are some tips to hold onto yours.

- Get a good quality bike lock - the more expensive your bike, the more you should spend, a good guide is to spend 10 - 20% of the cost of the bike on the lock. Solid 'D' locks offer good protection.
- Ideally the lock should have the Secured By Design Award or the Sold Secure Award.
- Use the lock! - even if popping into the shops for 2 minutes, many thefts are opportunistic.
- Lock to the best solid object you can find such as a cycle stand, railing or other street furniture. Ensure that the bike and lock cannot simply be lifted over the object.
- Consider using a stand-alone alarm (from £2) or a padlock with a built in alarm.
- Leave your bike where it can easily be seen by others or under CCTV surveillance.
- Remove anything that can't be secured, lamps, pumps, quick release saddles etc.
- Secure quick release wheels with your main lock or a separate cable which should also have the Secured By Design Award or the Sold Secure Award.
- Use Setectamark, Cremark, Veloeye, or other bike marking product and use visible sticker to advise the bike is security marked.
- If you regularly park it away from home and in the same location (e.g. work) as your employer, council, etc.) if they would consider installing bike security lockers.
- If you store the bike in a shed or garage fit a ground or wall anchor and lock your bike to it.
