### Item 2 - Minutes of the Last Meeting

### Item 5 – Roads and Transport

6. <u>A96 Dualling</u> The status of this project was raised as a question at Scottish Parliament with SG affirming their commitment to improving A96 journeys, safety and congestion issues. Improved transport connectivity along with bypassing affected communities where required. There is an ongoing consultation to get feedback on A96 connectivity – Frank circulated a draft BCC response – reiterating previous comments made by the BCC. Individuals are also encouraged to respond.

9. Stan had been in contact with Brian Strachan and advised the A96 Bus Stop design work had started. BCC awaiting update.

10. <u>Insch Strategic Needs Assessment</u> Frank presented a report on the outcome of the recent Integration Joint Board discussions on Insch Hospital. The IJB decision not to reopen in-patient beds in the existing Insch War Memorial hospital leaves us for the foreseeable future with the lowest ranked option for healthcare for Insch.

The decision-making process was flawed. The recommendations had not been seen by members of the stakeholder work group and were not representative of the collective views of the workgroup. Decision making did not follow the process proscribed by Health Improvement Scotland.

A number of issues were misrepresented in the IJB meeting on 6<sup>th</sup> June 2022. Members expressed disappointment at the IJB decision

### BCC resolved to:

1. Minute observations on the IJB process (see appendix A)

2. Work with the Friends of Insch Hospital to understand the consequences of the IJB decision and to evaluate options moving forward.

3. When the Health and Social Care Partnership commence consultation on either the short term, interim arrangements or the new build options, BCC must engage with the consultation to represent the views of the community.

11. Strawberry Fayre was a great success and was very well attended. BCC stall with posters manned by Andy and Hugh.

#### 2. IJB Meeting 1/6/22 Conclusions

The meeting accepted the recommendations as proposed: i.e.

- Further work on new builds for inpatient beds at either Insch or Inverurie
- No further work on options with in patient beds in existing Insch War Memorial Hospital building.
- Further work on re-designation the current Insch Hospital as a wellbeing hub.
- Immediate work in interim arrangements to provide alternatives for in -patent beds for patients from Insch area.

#### 3. IJB Meeting 1/6/22 Process

The meeting was chaired by Rhona Atkinson of NHS Grampian. Four councillors participated and four other voting representatives of NHS Grampian were present.

The case was presented by Phillipa Jensen (Health & Social Care Manager) and Geraldine Fraser (Partnership Manager) supported by Pamela Milliken (Chief Officer) of Aberdeen Health and Social Care Partnership. Several other non-voting members of the IJB and NHS and Aberdeenshire officers were present.

Community Representatives Frank Musgrave (BCC) and Chris Humphries (FOIH) were allowed to talk for 10 minutes at the start of the agenda item. but were connected by telephone rather than joining the meeting by zoom and were muted after the allocated time to prevent them from contributing further, even to correct inaccuracies.

Councillors picked up on the point about promises made by members of the Scottish Government. However other members of the board emphasised that no priority should be given to Insch rather than other parts of Aberdeen and the indication was that the IJB might like to do a full inventory of capital expenditure requirements across Aberdeenshire before submitting any requests for capital allocation to the Scottish Government.

While discussion on Scottish Government funding was informative, unfortunately there was no acknowledgement of the points made by community representatives about current health care deficiencies in Insch. The stakeholder workgroup established that no risk assessment had been conducted on the impact on healthcare in the area of closing Insch Hospital. The stakeholder workgroup heard moving evidence that the difficulty in obtaining in-patient beds is resulting in inadequate health care in the Insch area.

Councillor Keating (Inverurie) proposed that further work on new builds be limited to an option in Insch. (option 4) There was no seconder.

Councillor Grant (W.Garioch) proposed that work on interim arrangements should specify in patient beds "in Insch". This amendment was defeated.

Before amendments were discussed and voted on the Chair indicated her preference to support the suite of recommendations as presented. The agenda item ended with the meeting voting to accept the recommendations as proposed.

#### 4. IJB meeting 1/6/22 Reflections

It is ironic that this was the Integration Joint Board. The options developed by the stakeholder groups had the explicit intent of improving cooperative and seamless working between health and social care staff and to improve job satisfaction and staff retention. The "Integration Board" defaulted to "big hospital " mode.

While the bulk of the work had been done through a Stakeholders workgroup, the workgroup were not involved in the preparation of and did not have sight of the "final" report, the report considered by the IJB was not representative of the Stakeholder workgroup views.

The recommendations did not reflect the process initially outlined to the Stakeholders work group, which had been mandated by Healthcare Improvement Scotland.

Officers and Board members fell over themselves to emphasise how good the community consultation was, while at the same time riding roughshod over the community input. One member asserted that community input represented the "loudest voices" rather than measured profession inpu*t*. The board was however keen to insist that community input was essential going forward both on interim arrangements and in developing the case for new build beds.

While promoting the benefits of consultation, the meeting were further not made aware that the stakeholders meeting acknowledged that the SNA report was not representative of community input.

A number of issues were mis-represented during the IJB meeting:

- It was stated that Insch patients are able to access beds in Inverurie or the Jubilee Hospital, Huntly. Evidence presented by the local medical practitioners suggests that this is not the case.
- It was stated that clinicians involved supported additional beds in Inverurie rather than Insch. That is completely incorrect. It was the clinicians which developed and promoted the options for beds in Insch. The relative scoring would have been different if that had been the case.
- It was stated that modifying Insch Hospital, even as an interim option, did not present value for money. Since the estates advice then went on to say that viability and cost would need to be determined via a design team this assertion is unsubstantiated. (FOIH had been trying to obtain this information from NHSG and also have different independent advice.)

#### 5. Implications for Insch and district healthcare of IJB decision

- By default we now have the lowest ranked option for healthcare in Insch.
- Interim arrangements to replace in patient beds in the area are essential and urgent.
- The timescale for any new build is likely to be extended.

#### However:

- we still have the longer term option of a new build at Insch with in beds.
- Although the IJB would not commit to having the interim beds in Insch, this does not rule out the option of interim beds in Insch, for example in a modular building

#### 6. Recommendations

1. Minute observations on the IJB process

2. Work with the Friends of Insch Hospital to understand the consequences of the IJB decision and to evaluate options moving forward.

3. When the Health and Social care partnership commence consultation on either the short term, interim arrangements or the new build options, BCC must engage with the consultation to represent the views of the community.
