#### **Item 4 - BCC Business**

4. <u>Decisions Since Last Meeting</u> BCC representative (Frank) attended further meeting on the 1<sup>th</sup> December as part of the ongoing Insch Hospital Strategic Needs Assessment consultation. Frank advised he had discussions with local GP Dr Davies and Chris Humphries of Communities Hospital Association who agreed that we continue to need to engage with the process despite the 'lack of confidence' concerns about the pre-determination of the assessment and that closure outcomes were a foregone conclusion. Frank keen to not be seen as a 'human shield.' BCC therefore would wish to reserve the right to comment as required. Friends of Insch Hospital group looking for wider membership.

Next Stage is a discussion panel with Volunteers in and around late January 2022 but delayed due to staff redeployment.

5. <u>Financial Statement</u> Wally advised the finances were in a good position standing at ~£3700. Recent donation to Insch Larder was gratefully received.

- 6. <u>Queens Platinum Jubilee</u> Bonfire to be held at Tillymorgan on day while community groups will have a beacon on Mither Tap. Oyne looking at various options. No plans at Insch unless part of the Strawberry Fayre (BCC to make separate arrangements on this for August).
- 7. <u>Licensing Board (Gambling Premises) Guidance</u> Frank advised on updated and clarified information requirements for such establishments. There are few in BCC area but we voiced our support for proposed changes via online consultation.
- 8. Greenspace Herbaceous Perennials Expressions of interest have had little response. Wally

unsure of why changes to present system are required. Hugh continues to promote on website.

9. Giant Hogweed Andy approached by River Don Trust who are looking for support to tackle and treat the ever increasing spread of plants along the section of river near Pitcaple. Drone footage being prepared to increase awareness. Cllr Smith stressed that landowner is required to combat it. Andy proposed we support the Trust in its efforts to obtain Lottery Funding and all agreed.

# Item 5 - Planning

- 11. <u>Planning Report Stuart Rennie presented the planning report.</u> Application at a field at Oyne for a storage shed and parking for a local business local objections, flood risk and Roads objection this to be monitored until wider community stance known. Retrospective pp sought for a machine workshop at a rural site near Meikle Wartle but limited concern. Stuart highlighted another proposal at Brownhills near Daies to relocate a previously approved dwellinghouse (1 of 3 granted as part of rural brownfield site) some issue with fact that the relocated site had never been previously developed itself just close to. Others took view that no real impact.
- 12. <u>An update on Local Place Plans</u> was provided but it was thought that there would be little interest in this owing to the lack of action arising from the Place Standards exercise in Insch undertaken 3 years prior. Andy to check on progress. Oyne looking to do a smaller scale exercise to enable public funding opportunities to be explored.

- 13. <u>New Aberdeenshire LDP</u> due shortly after Examination, this included Affordable Housing Paper circulated previously. Latest update that this was delayed until spring time. This would be the new plan and policies to which development applications would need to comply with.
- 14. <u>Delegated Planning Powers</u> It was highlighted that Scheme of Delegation changes are being sought where planning applications with a total of 10 objections or fewer can be approved by Officers without being referred to Area Committees. It was highlighted that local members can still request referral Cllr Smith stated that all three local councillors had to agree to this.
- 15. <u>Discussion on Prime Agricultural land policy</u> (presumption against its loss). This stating that BCC had developed a strong stance on this that others were now following. It was highlighted however that there is a concern about proposals still being permitted on these areas. A Local Member Officer working Group was to be formed by Aberdeenshire Council to establish best practice. Stuart to raise concerns on the erosion of the application of this policy requirement. Cllr Smith to check on working group status.

Item 6 - Roads and Transport

- 16. <u>20 mph speed limit roll out No timeframes are known for this.</u> Issues of speeding still major concern in all communities Discussions Groups are due to get underway and paper had been to ISC. Policy approach needed first before working out how to implement.
- 17. <u>Public Transport</u> Ready to Go User Survey published. Stan queried whether it was this service or A2B that served Culsalmond he will speak directly to operators. Free Bus Travel for Under 23's promoted on FB.
- 18. <u>Insch station disability access</u> Cllr Smith highlighted that Nestrans Disability Access Study was underway after grant assistance to look at options including footbridge and lifts as per BCC

No timeline for this to be rectified. Andy and Stan to discuss separately.
