## Minutes of the Meeting held on 02 March 2020

**Waste Management Overview:** Nom Wright (AC) sent apologies as he was unable to attend the rescheduled meeting and hopes to attend the next meeting.

**Consultation on Library Services:** Katie Fairweather gave an overview of the consultation which is specific to each local library – in this case Insch. The online survey closed on 29<sup>th</sup> February 2020, with paper responses open until 6<sup>th</sup> March 2020. In addition, any comments / suggestions can be made at any time at the library. The survey is looking at opening hours and ways to fully utilise Libraries and facilities. Digital library services, including 'Playlist for Life' (an Alzheimer's music resource) using FreeGal service were discussed. Although Council budget cuts are likely Insch Library is not looking to be closed.

The BCC had promoted the consultation on its website and Facebook page. Katie to provide feedback and further information to BCC so library services could be further promoted.

### Item 3 – Police Report

4. The Chair read out items from the Police Report (Annex A), which had been distributed to CCs prior to the meeting. Further to a feedback request from the Police (via AC) as to how to improve the Police Report for CCs it was suggested the general safety / contact information at the back of the report could be made into a poster which could be displayed within community notice boards, Facebook pages etc. A monthly or seasonal message / update was also suggested. The Chair to respond.

### Item 4 – BCC Business

6. Decisions Since Last Meeting None.

7. Financial Statement Wally advised there had been no significant change in the accounts and the balance is predicted to be ~£3500 for financial year end. Wally also reminded everyone to claim

operational BCC expenses (e.g. printing, travel to site visits, etc).

8. BCC Elections The Sec confirmed that due to the number of CCs three year terms coming to an end AC had advised elections would need to be held this year (to co-inside with June AGM). Alison Cumming (AC) is organizing elections for all CC and will send further information (e.g. timeframe and election forms). The Sec to keep everyone updated and to send out election forms when available.

9. BCC Insurance Zurich Insurance renewal is due on 1<sup>st</sup> April. The Sec had contacted Zurich regarding the potential additional costs of adding the projector to the policy. It was noted that although the projector had been acquired for £100 its replacement value was much higher. Zurich confirmed that based on this value there would be no additional costs to the premium, due to the £100 excess. Stuart to investigate costs of a replacement projector. Once received a decision to be made whether or not to add the projector to the policy.

10. Important Dates The Chair ran through the list of forthcoming important dates which had been circulated prior to the meeting.

### **Item 5 - Planning**

11. Planning Applications Stuart provided a summary of the 13 applications since the last meeting in January, which had been circulated by email prior to the meeting. No actions required.

A discussion on footpaths within Chapel of Garioch took place in light of recent planning applications at the edge of the village. Stuart advised the most recent application already had outlining planning permission. The absence of a footpath would be a material consideration, not a policy issue.

12. LDP2021 12. LDP2021 Stuart provided an update on the LDP2021. The Report of Examination of the Strategic Development Plan has been published. The Reporter has increased the housing allowance for Aberdeenshire (over and above the figures used for the LDP2021 MIR) by 940 dwellings for the period 2020 - 2032, of which 376 will be required in the Rural Housing Market Area. Sites may, therefore, need to be added to the Draft LDP, possibly including some in the BCC area. However, numbers in the Draft LDP may incorporate some spare capacity, in which case additional houses would not be required.

### **Item 6 - Roads and Transport**

13. Dualling A96 Update Stuart gave an summary of potentially 'new' information relating to the Alignment of the Oyne / Colpy section of the A96 Dualling. This 'new' information appears to have been released / presented in August 2019, whilst public comments (including BCC comment) occurred in May 2019.

### **Item 7 - Infrastructure and Services**

14. Property Flood Resilience Survey Scott to publicise on Facebook page.

NE 400Kv Reinforcement Scottish and Southern Electricity Networks (SSEN), operating as Scottish Hydro Electric Transmission (SHET) under licence, has plans to reinforce the existing 275 kV overhead line connecting the substations at Black hillock, Keith, Kintore and Peterhead to enable operation at an increased voltage of 400 kV. Stuart has carried out some preliminary analysis, which indicated 13 places / towers within the BCC area that could have varying impact related to noise / changes in noise associated with the upgrade. Frank & Chair to review. Deadline for responses 13<sup>th</sup> March 2020.

24. Inch Train Station Survey The Chair had been in contact with Cllr Argyle regarding an update. The next stage of appraisal by NESTRANS is in progress – no schedule has been given. The Chair passed on thanks from Cllr Argyle for all the work the BCC has done to promote and lobby for station accessibility. Stuart to address a written comment made by AECOM which misrepresented BCC views.

Scottish Government National Prioritisation is currently underway with prioritisation of submitted flood studies expected in June 2020. Inch is likely to have a low priority.

26. Unstable Wall – The Meadows Stuart advised that he had been liaising with Mr Birkhead (Inch Resident) and AC, and advised the wall is currently being repaired.

27. Traffic - Commerce Street Inch Mr Grant (Inch Resident) advised that he is awaiting a response from AC.

## Bennachie Community Council Police Report for FEBUARY 2020

### **Community Council Report**

This report covers progress we have made in dealing with your priorities for the Bennachie Community Council area during the period 20/01/2020 to 17/02/2020.

The report aims to highlight emerging issues in your area, and to provide crime prevention advice and guidance to Community Council members and residents you represent. Our focus is to reduce crime and disorder, help create safer communities and respond effectively to local concerns.

### **Community Policing Priorities**

#### **Antisocial behaviour, Violence and Disorder:**

On 9<sup>th</sup> of February 2020 a Vandalism and an assault occurred at a property on Rannes Street, Inch. A male has been reported to the Procurator Fiscal regarding this.

On 13<sup>th</sup> February 2020 a House breaking where a car was damaged by fire near Meikle Wartle, was reported to Police. A suspect has been identified and enquiries are ongoing.

On 13<sup>th</sup> February 2020, on Market Street, Inch a Breach of the Peace and an assault involving a male and female were reported to the Police. The female was issued with a FPN and the male has been reported to the Procurator Fiscal.

During this time Police attended calls where they assisted members of the public and provided advice.

#### **Acquisitive Crime:**

On 20<sup>th</sup> January 2020, a fraud was reported to Police where a piece of machinery had been purchased online. Once the money had been transferred the piece of machinery didn't arrive. Enquires are ongoing into this.

There were no further instances this month.

#### **Road Safety & road crime:**

On 12<sup>th</sup> February 2020 at Church Avenue, Inch a 23 year old male was stopped in relation to Drug driving. On analysis of results he will likely be reported to the Procurator Fiscal.

During this time Police attended numerous reports of poor driving and RTC's where no conduct amounted to a criminal matter.

### **Community Engagement & Reassurance**

#### **Various fraud/scams**

There are numerous fraud and telephone based scams doing the rounds at the moment and I would ask that you encourage/remind that the bank/reputable organisations will not phone you

and request personal details over the phone. If there is any dubiety attend at your local branch. Do not transfer any money over the phone no matter how plausible these individuals may seem.

### **New mobile phone technology to increase police officer visibility in local communities**

Police officers in the North East will start using mobile devices as part of their operational duties which will increase their visibility within local communities.

Officers will be able to access a wide range of police systems while out on duty without the requirement to return to a police station and log on to a computer.

This means that officers will be able to spend more time working within the community, dealing with incidents, engaging with members of the public, supporting victims and focussing on crime prevention.

Previously, when officers dealt with a crime, they would have to return to base to record details of an incident on the appropriate systems and complete paperwork.

The new mobile devices will mean that every Community Policing Team officer, and those with a front line operational role, will be able to connect to police systems whilst working remotely.

The mobiles will provide apps enabling officers carry out checks and file crime reports. Officers will also be able to type statements directly to the device through the use of its digital notebook function Pronto which will obtain an electronic signature from victims and witnesses.

### **Bike security**

Keeping hold of your bike should be easy. More of us take to the roads as the better weather approaches so here are some tips to hold onto yours.

- Get a good quality bike lock - the more expensive your bike, the more you should spend, a good guide is to spend 10 - 20% of the cost of the bike on the lock. Solid 'D' locks offer good protection.
- Ideally the lock should have the Secured By Design Award or the Sold Secure Award.
- Use the lock! - even if popping into the shops for 2 minutes, many thefts are opportunistic.
- Lock to the best solid object you can find such as a cycle stand, railing or other street furniture. Ensure that the bike and lock cannot simply be lifted over the object.
- Consider using a stand-alone alarm (from £2) or a padlock with a built in alarm.
- Leave your bike where it can easily be seen by others or under CCTV surveillance.
- Remove anything that can't be secured, lamps, pumps, quick release saddles etc.
- Secure quick release wheels with your main lock or a separate cable which should also have the Secured By Design Award or the Sold Secure Award.
- Use Setectamark, Cremark, Veloeye, or other bike marking product and use visible sticker to advise the bike is security marked.
- If you regularly park it away from home and in the same location (e.g. work) as your employer, council, etc.) if they would consider installing bike security lockers.
- If you store the bike in a shed or garage fit a ground or wall anchor and lock your bike to it.
