#### Item 5 - Roads and Transport

10. <u>A96 Dualling</u> The status of this project was raised as a question at Scottish Parliament with SG affirming their commitment to improving A96 journeys, safety and congestion issues. Improved transport connectivity along with bypassing affected communities where required. There is an ongoing consultation to get feedback on A96 connectivity – Frank advises BCC and will respond on behalf of the BCC. Individuals should respond.

- 12. <u>Lights at Daies</u> work to repair Armco barrier were due to commence, especially after a number of light failures and near misses.

# Bennachie Community Council Planning Summary

#### MAY

The following planning applications were discussed:

#### APP/2022/0945

PPP for 'Plot 4' Adjacent to Braeside Meikle Wartle. Several members felt this proposal would have an adverse landscape impact due to creation of a strip of 'ribbon development' extending into what is currently open countryside.

#### APP/2022/0830

Westside, Premnay. Renovation of existing croft house and extensive additions.

This would entail complete refurbishment of the existing cottage, a large linked extension to the east and two smaller extensions. There are no apparent adverse impacts.

#### APP/2022/0934

Caravan park at Drumrossie Home Farm South. Proposal for caravan park comprising 21 stances for privately owned holiday lets.

The application was discussed in great detail. Issues included access for emergency vehicles down the narrow access road, junction of access road with Western Road, contaminated land, trees and hedges, etc. It was felt that BCC needed to submit a 'holding objection' until more information became available on such issues
